## HHNA Design/Conservation Overlay Update

Our Harkness Heights Neighborhood Association (HHNA) Overlay project has made great progress since our July Newsletter update. On August 22, our 25-member Overlay Task Force met with our newly elected City Councilwoman, Amanda Sandoval, who enthusiastically endorses our overlay. Amanda introduced two new staff members, Naomi Grunditz and Matthew Bossler, who will assist District 1 neighborhoods in pursuing their land-use issues. Naomi and Matthew were interns with Pel-Ona Architects & Urbanists and worked on their HHNA study last winter. Also participating in the August 22 meeting was Brad Johnson, the lead City Planner managing our overlay application process through the zoning approval.

Since August our smaller working group (Greg Sader, Joan Mobley, Peggy Lentz, Keith Chamberland, and Tom Mobley) has been working with Naomi and Matthew to respond to questions posed by the Planning Department and tighten up any open issues in our proposal for an overlay. The Planning Department is in support of a significant majority of our proposal, and we hope to reach a consensus shortly.

The Harkness Heights community will have a chance to review and approve the proposed overlay before it will be submitted for review and approval by the Zoning Board and City Council in the spring.

Steps you can take to deter porch pirates include: 1) Ship to an Amazon Locker (available inside Safeway at 44th and Lowell, 2) Ship to FedEx Office or UPS Store, 3) Ship to neighborhood grocery store, convenience store, or other businesses, 4) Ship to work address, 5) Ship to a friend or neighbor that you know will be home, and 6) Install an outdoor security camera or doorbell (Officer Robert Gibbs, Denver Police District 1).

#### Harkness Heights History

Denver's first electric Christmas lights shone in our very own neighborhood at 4282 Grove Street in 1914! According to Phil Goodstein in his book 'North Side Story, Denver's Most Intriguing Neighborhood' (p. 507), the son of electrician David Dwight Sturgeon was too ill to get up to see the family Christmas tree in 1914. To make his son's holiday brighter, Mr. Sturgeon dipped lights bulbs in brightly colored paints and hung them in a tree outside his son's window. Denver subsequently boasted that David Sturgeon was the father of electric Christmas lighting everywhere, although in 1895 President Grover Cleveland requested that the White House family Christmas tree be illuminated by hundreds of colored electric light bulbs (https://www.loc.gov/everyday-mysteries/item/ who-invented-electric-christmas-lights/).
